1. Sweepstakes Description: Sour Jacks QuickChek In-Store WedgeHunt Sweepstakes begins on 03/20/2017 at 12:00PM (Eastern Time (US & Canada)) and ends on 04/20/2017 at 11:59 PM (Eastern Time (US & Canada)) (the "Promotion Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Promotion In Motion Companies, Inc. ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of entries and the overall administration of the giveaway. All social posts must include include “#WedgeHunt”. Any social post without the #WedgeHunt hashtag will not be counted.

b. PHOTO UPLOAD AT A WEDGEHUNT FLAVOR LOCATION (TO BE CONSIDERED FOR THE FIRST PLACE PRIZE) Entrants must take a photo of a WedgeHunt in-store shelf dangler, post it to social and tag their location. All social posts must include include “#WedgeHunt”. Any social post without the #WedgeHunt hashtag will not be counted. For each photo taken, the user will receive an additional entry into the Sweepstakes.
